OZ is the sole member of Och-Ziff Holding II LLC ("OZHII"), the general partner of OZII. As a result, OZ has voting and dispositive authority over the Common Stock reported in this Schedule 13G. OZHC serves as the sole general partner of OZ. As such, OZHC may be deemed to control OZ and, therefore, may be deemed to be the beneficial owner of the Common Stock reported in this Schedule 13G.
