Explanation of Responses:

- Pursuant to the Endo International plc Directors Stock Election Plan, on December 23, 2013, Mr. Higgins elected to receive 100% of his 2014 cash retainer fees and 100% of his 2014 meeting fees in Endo ordinary shares. At the time that the retainer fees and meeting fees would otherwise have been payable, the number of shares of Endo ordinary shares are fixed and reported as of such date in Table I as an acquisition of securities. These cash retainer and meeting fees are payable to Mr. Higgins in consideration of his services on the Endo International plc Board of Directors for the first quarter of 2014.
- This number represents ordinary shares. Mr. Higgins' beneficial ownership also includes 1,016 restricted stock units.
