OZII is a wholly-owned subsidiary of OZ and, as such, OZ may be deemed to be the beneficial owner of Ordinary Shares, nominal value \$0.0001 per share ("Common Stock") held in the Accounts managed by OZII. OZ is the sole member of Och-Ziff Holding II LLC ("OZHII"), the general partner of OZII. As a result, OZ has voting and dispositive authority over the Common Stock reported in this Schedule 13G. OZHC serves as the sole general partner of OZ. As such, OZHC may be deemed to control OZ and, therefore, may be deemed to be the beneficial owner of the Common Stock reported in this Schedule 13G. OZM is the sole shareholder of OZHC, and for purposes of this Schedule 13G, may be deemed to be the beneficial owner of the Common Stock reported in this Schedule 13G. Mr. Daniel S. Och is the Chief Executive Officer and an Executive Managing Director of OZM.
