- On December 31, 2014, the cumulative 3-year performance period for Ms. Manogue's February 22, 2012 grant of performance shares concluded. At this time, the performance shares were converted into 8,105 ordinary shares. Of this amount, 4,132 shares were withheld by the issuer to satisfy tax obligations on shares acquired and 3,973 shares were transferred to Ms. Manogue effective immediately.
- This represents the automatic conversion of performance shares granted to Ms. Manogue on February 22, 2012 to ordinary shares of Endo International plc pursuant to the terms of the underlying award agreement.

Know all by these present that the undersigned hereby makes, constitutes and appoints Caroline B. Manogue, Daniel A. Rudio, Richard Casten and Justin Dailey as the undersigned's true and lawful attorneys-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of each of the undersigned to:
