- These securities were granted to Mr. Pera in consideration of his services as President, Par Pharmaceutical, a subsidiary of Endo International plc.
- Represents the right to buy ordinary shares, par value \$0.0001 per share, of Endo International plc.
- These stock options are generally exercisable 33 1/3% per year on each of August 10, 2018, August 10, 2019 and August 10, 2020.
